

College Park Reopen Plan August, 2020

Welcome Back Cobras

On behalf of the staff at College Park School, I would like to welcome you back to school. It has been a little over 5 months since we closed the building and moved to remote learning. We are excited to reopen the doors and welcome students back on September 8th. In the past two weeks, we have been developing plans for College Park based on the guidelines from the Province of Saskatchewan and LPSD. Homeroom teachers will be in contact with families over the next few days.

Enhanced Safety Measures

This fall, we will have enhanced safety measures. We are increasing our sanitization of high touch areas throughout the school and classroom areas. An important part of our plan is proper hand washing and sanitizing. There will be regular scheduled times to wash hands, such as before and after eating, and before and after recess. Hand sanitizer will be available in all classrooms and entrances. Students will also be instructed on and encouraged to practice social distancing.

All students will be provided two reusable masks. Masks are required for all students when riding a bus, and are also required in the school for grade 4-9 students in common areas and where social distancing is not possible. When seated at desks engaged in individual work, students may choose to remove their masks. Masks must be worn during whole group instruction. Although not required, students in K-3 are encouraged to wear masks as well. There is a supply of disposable masks available for students, staff and visitors. Parents and visitors will require an appointment to enter the school.

Students displaying Covid symptoms

It is expected that parents will do a daily check of their child for symptoms of Covid-19 and not send their child to school if exhibiting symptoms. The following link from Saskatchewan Health is a good source of information. Staff will also monitor students while at school. If a student develops symptoms at school or upon arrival at school, the student will move to the Illness in Care room, and the parent or guardian will be notified to pick up the student immediately. The student will be supervised while in the Illness in Care room.

Busina

Busing will be available for College Park Students. All students will be required to wear a mask on the bus, regardless of grade. In order to ride the bus, students must be registered and sit in their assigned seat. All buses will have enhanced cleaning measures in place between runs and routes. Bus route cancellations will be posted on the LPSD website and we encourage parents to check daily.

Extra curricular activities

At this time, all field trips and extra-curricular activities are postponed. There will also not be any before school care.

School Based Supports

College Park will have counselling support available for any students requiring mental health and social/emotional support.

CAREGIVER INFORMATION

Caregivers are required to conduct a daily selfassessment for children in their care to determine if they are healthy and able to attend school.

If your child answers "YES" to any of the above questions, begin self-isolation immediately. Contact Public Health at 8-1-1 for guidance and inform your child's school that they will not be in attendance.

If your child begins exhibiting symptoms of COVID-19 while at school you will be asked to pick them up immediately.

Children who regularly have symptoms that may be mistaken for COVID-19 symptoms are encouraged to provide a medical note to the school so that the teacher and necessary staff are aware.

Safety Measures

HIGHLIGHTS OF THE REOPENING LPSD SCHOOLS PLAN

PHYSICAL DISTANCING



In order to limit contacts, cohorts will be created and the number of teacher exchanges reduced. Staggered entry/exits and breaks will be in place. Directional signage around school to encourage physcial distancing

DAILY SELF-ASSESSMENTS & ILLNESS POLICY

Families, students and staff to self monitor and must stay home if they are sick or have symptoms. Schools will designate an isolation area for students or staff who become sick while at school. Parents/caregivers to pick up students promptly if they become sick.

MASKS



Mask will be required for staff and students in Grades 4-12 where physical distancing cannot be maintained. LPSD will provide two reusable cloth masks with disposable masks available at schools. All visitors and guests will be asked to wear masks while in the school.

HAND HYGIENE

Staff and students will practice frequent hand washing and sanitizing. Hand sanitizer will be placed in common areas and classrooms.



TRANSPORTATION



Buses will be cleaned/sanitized between runs and masks will be required by all passengers. Parents/caregivers are encouraged to transport children when possible.

ENHANCED CLEANING



Frequent and enhanced cleaning/sanitization with increased attention to high points of contact, shared equipment and commonly used areas.
